Exhibitor Information

1. All dogs nine (9) months of age or older that are registered with the American Kennel Club or that have AKC Limited Registration are eligible to participate.
2. Dogs should be physically sound. Dogs that are lame, blind, or deaf or have open sores shall not be eligible. No dog shall compete if it is bandaged, stitched or in any way has anything attached to it for medical purposes. If course conditions warrant, protective footwear may be worn if approved by the Judge.
3. At the handler's option dogs may wear flat buckle collars, snap collars, or slip collars, but there shall be no hanging tags or attachments. Pinch collars, electric and dummy electric collars are prohibited. Prong and electric collars (live or dummy) are prohibited on the grounds. Food and toys are not permitted in the course area.
4. You are responsible for cleaning up after the animals in your care. It is expressly understood that every dog at this test/trial is in the care, custody, and control of its owner or handler during the entire time the dog is on the trial premises. Mid Jersey Labrador Retriever Club is not responsible for the loss of, damage to, or death of any dog exhibited, or the possessions of any participant, whether the result of accident or any other cause.
5. To prepare for this test, familiarize yourself with the 12 required elements found in the Farm Dog Certified (FDC) Test Regulations. Farm Dog Certification and AKC Herding Regulations are available from the American Kennel Club, 5580 Centerview Drive, Suite 200, Raleigh, NC 27606- 3390 or online at <https://www.akc.org/sports/herding/farm-dog-certified-test/> . Exhibitors are expected to be familiar with the rules and regulations.
